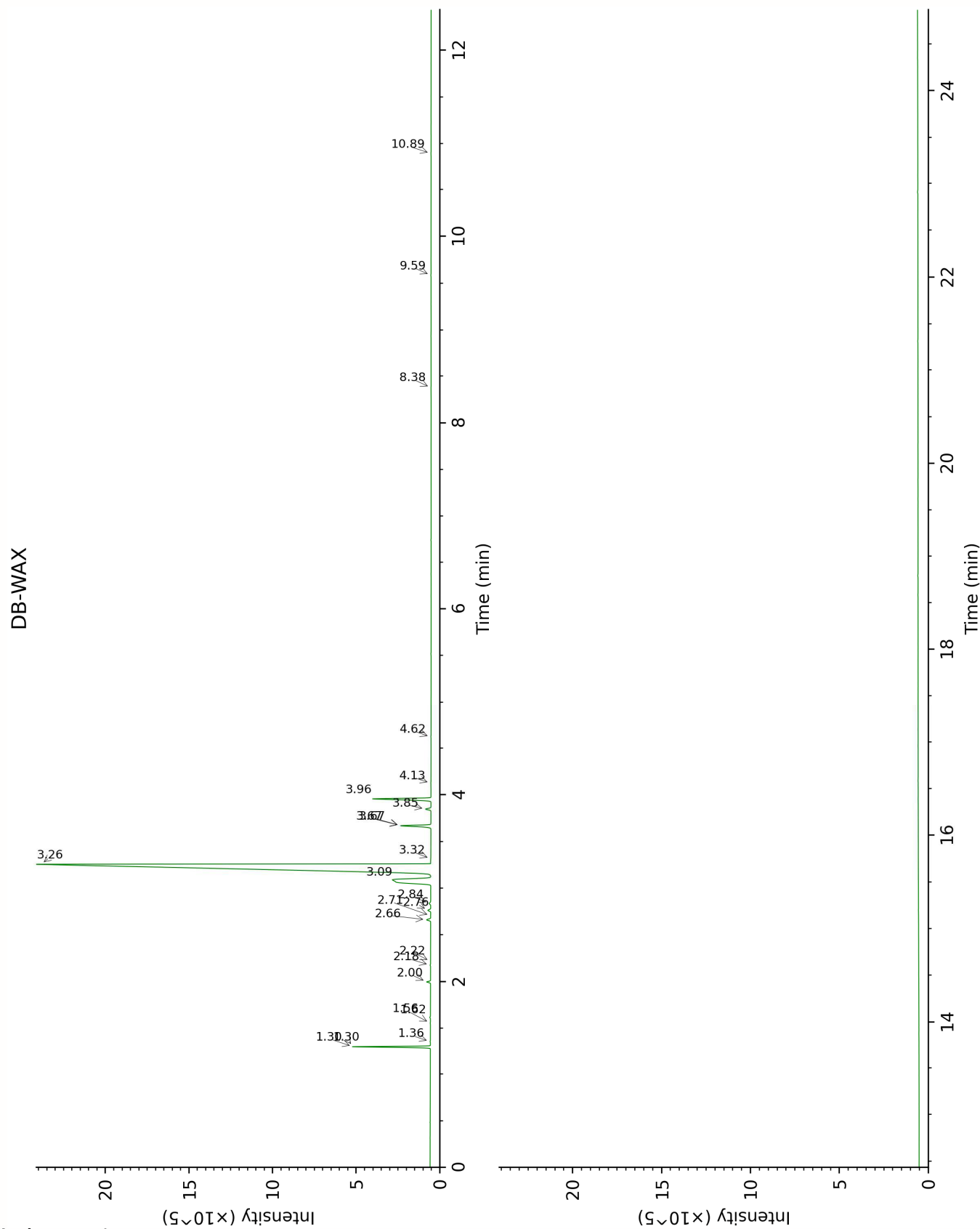

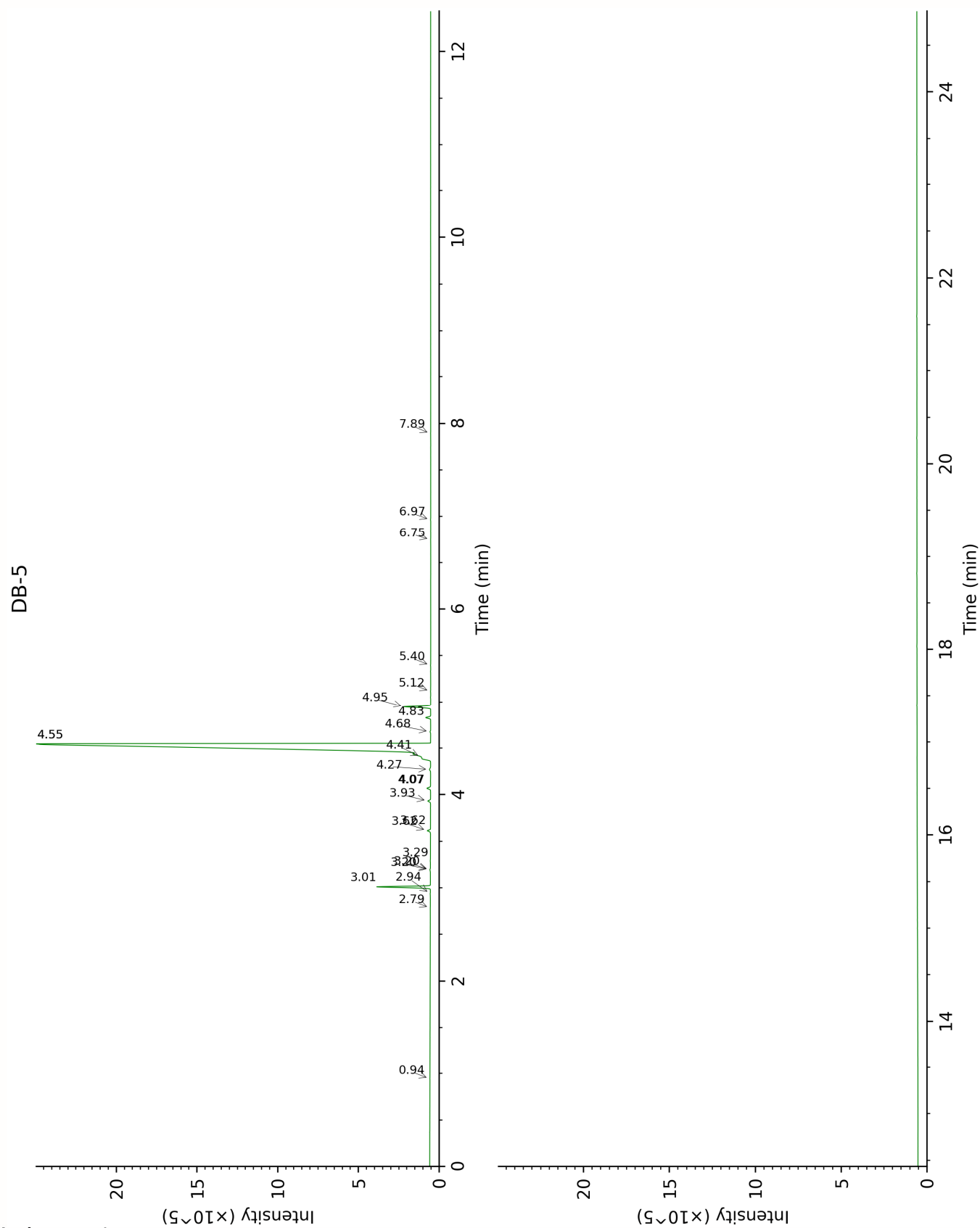
About "consolidated" data: The table above presents the breakdown of the sample volatile constituents after applying an algorithm to collapse data acquired from the multi-columns system of PhytoChemia into a single set of consolidated contents. In case of discrepancies between columns, the algorithm is set to prioritize data from the most standard DB-5 column, and smallest values so as to avoid overestimating individual content. This process is semi-automatic. Advanced users are invited to consult the "Full analysis data" table after the chromatograms in this report to access the full untreated data and perform their own calculations if needed.

Unknowns: Unknown compounds' mass spectral data is presented in the "Full analysis data" table. The occurrence of unknown compounds is to be expected in many samples, and does not denote particular problems unless noted otherwise in the conclusion.
