## 4. First-aid measures

### Description of first aid measures

#### **General advice**

IF exposed or concerned: Get medical advice/attention. Immediate medical attention is required. Show this safety data sheet to the doctor in attendance.

#### **Inhalation**

Aspiration into lungs can produce severe lung damage. If breathing has stopped, give artificial respiration. Get medical attention immediately. Avoid direct contact with skin. Use barrier to give mouth-to-mouth resuscitation. If breathing is difficult, (trained personnel should) give oxygen. Get immediate medical attention. Delayed pulmonary edema may occur. Remove to fresh air.

#### **Eye contact**

#### **Skin contact**

#### **Ingestion**
