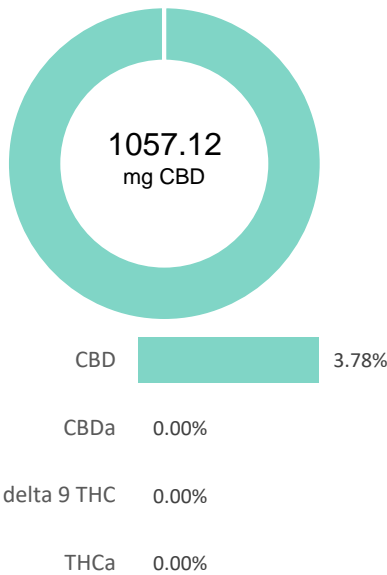

Total Potential CBD = CBDa * 0.877 + CBD
