Total Potential THC and CBD: Liquid chromatography occurs at room temperature and does not decarboxylate any cannabinoids, thereby yielding separate values for THCa, THC, CBDa and CBD, which are then combined to derive the Total Potential THC and Total Potential CBD result using the following formulae:

Total Potential THC = THCa * 0.8777 + Δ9-THC + Δ8-THC

Total Potential CBD = CBDa * 0.8777 + CBD

LOQ = Limit of Quantitation; LOD = Limit of Detection. Cannabinoids for flower and trim reported as received.
